- The Associations Law was amended in 2020 and 2022 to mirror the world- renowned laws and standards of the State of Delaware, meet the expectations of maritime and corporate clients, including public companies, and to satisfy international standards and regulations
- A variety of corporate structures: Corporation, Limited Liability Company, Partnership, Limited Partnership, Private Foundation, Not-for-Profit Corporation, etc.
